Privacy and Cookie policy purpose:

This policy:

- Acknowledges that Dwarf Sports Association UK aims to operate a sound policy to support the governance of personal information that all service users, team members, trustees and volunteers provide to the organisation. This policy (together with our terms and conditions of use) governs the use of personal information that you provide to us.

At Dwarf Sports Association UK we are committed to protecting and respecting the privacy of all our service users and customers.

This Policy explains when and why we collect personal information about people who visit our website and people who join DSAUK as members, how we use it, the conditions under which we may disclose it to others and how we keep it secure.

Who we are:

Dwarf Sports Association UK is the country's leading national disability sports organisation for people with restricted growth, supporting them and their families through making regular sporting opportunity accessible and enjoyable to anyone and everyone of restricted growth in the United Kingdom, regardless of their race, colour, ethnic origin, gender, location, sporting ability or financial support.

How do we collect information from you?

We obtain information about you when you use our website or contact us direct as well as when you become a member of DSAUK. For example, when you contact us about products and services, to donate, to take part in one of our sporting or fundraising events or if you register to receive one of our newsletters.

What type of information is collected from you?

The personal information we collect might include your name, address, email address, phone contact number, medical condition, IP address, and information regarding what pages are accessed and when.

If you make a donation online or purchase a product from us, your card information is not held by us, it is collected by our third party payment processors, who specialise in the secure online capture and processing of credit/debit card transactions, as explained below.

How is your information used?

We may use your information to:

- process a donation that you have made to us.
- process orders that you have submitted.
- to carry out our obligations arising from any contracts entered into by you and us.
- process membership applications
- dealing with entries into an event or competition.
- seek your views or comments on the services we provide.
- notify you of changes to our services.
- send you communications which you have actively signed up to or requested and that may be of interest to you. These may include information about campaigns, appeals, other fundraising activities, promotions of our associated companies' goods and services.
- process a job or volunteer application.

We review our retention periods for personal information on a regular basis.

We are legally required to hold some types of information to fulfil our statutory obligations (for example the collection of Gift Aid). We will hold your personal information on our systems for as long as is necessary for the relevant activity, or if it is set out in any relevant contract you hold with us.

Who has access to your information?

We will not sell or pass your information to third parties.

We will not share your information with third parties for marketing purposes.

Third Party Service Providers working on our behalf

We may pass your information to our third party service providers, agents subcontractors and other associated organisations for the purposes of completing tasks and providing services to you on our behalf (for example to process donations, entries information or classification requirements). However, when we use third party service providers, we disclose only the personal information that is necessary to deliver the service and we have a contract in place that requires them to keep your information secure and not to use it for their own direct marketing purposes.

Please be assured that we will not release your information to third parties for them to use for their own direct marketing purposes, unless you have requested us to do so, or we are required to do so by law, for example, by a court order or for the purposes of prevention of fraud or other crime.

When you are using our secure online donation pages, your donation is processed by a third-party payment processor, who specialises in the secure online capture and processing of credit/debit card transactions. If you have any questions regarding secure transactions, please contact us.

Security precautions are in place to protect the loss, misuse, or alteration of your information. When you give us personal information, we take steps to ensure that it's treated securely. When you are on a secure page, a lock icon will appear in the web browser URL address box.

Non-sensitive details (your email address etc.) are transmitted normally over the Internet, and this can never be guaranteed to be 100% secure. As a result, while we strive to protect your personal information, we cannot guarantee the security of any information you transmit to us, and you do so at your own risk.

Profiling

We may analyse your personal information to create a profile of your interests and preferences so that we can contact you with information relevant to you. We may make use of additional information about you when it is available from external sources to help us do this effectively. We may also use your personal information to detect and reduce fraud and credit risk.

Use of 'cookies' and domain information

Like many other websites, the Dwarf Sport Association UK website uses cookies. 'Cookies' are small pieces of information sent by an organisation to your computer and stored on your hard drive to allow that website to recognise you when you visit. They collect statistical data about your browsing actions and patterns and do not identify you as an individual. For example, we use cookies to store your country preference. This helps us to improve our website and deliver a better more personalised service. Cookies do not include personal details.

We use Google Analytics and Session cookies. These cookies are used to help us maintain an efficient website and monitor user activity (this is via anonymous reports). Google Analytics collects information about how people use this site. The statistical information about website activity is used to understand our customers' needs and to improve the website. Google Analytics stores information about what pages you visit, how long you are on the site, how you got here and what you click on. We do not collect or store your personal information (such as your name or address) so this information cannot be used to identify who you are.

Transferring your information outside of Europe

As part of the services offered to you through this website, the information which you provide to us may be transferred to countries outside the European Union ("EU"). By way of example, this may happen if any of our servers are from time to time located in a country outside of the EU. These countries may not have similar data protection laws to the UK. By submitting your personal data, you are agreeing to this transfer, storing, or processing.
